1. Installation of AMR compatible meters (RS 232 Port) at DTC, HT Consumers, Substation Feeder Meters and Cross Over Points and Meter Boxes at DTC and Cross Over Points along with 2.5 Sq mm cable
2. Installation of intelligent modems with store and forward features at all DTC, Substation feeder Meters, HT Consumers and Crossover Point supply.
3. To provide the MDAS software module for Meters /Modems in the scope and successful integration of your MDA module with MSEDCL's existing Meter data Acquisition System, MSEDCL's legacy applications and software solutions provided by M/s L&T
4. Provisioning of Bandwidth for the above towns for 5 years
5. Facility management for 5 Years


