**ORDER PASSED ON 24.08.2016.**

1. The applicant filed present grievance application before this Forum on 05.07.2016 under Regulation 6.4 of the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulations, 2006 (hereinafter referred to as said Regulations).
2. Non applicant, denied applicant's case by filing reply dated 12.08.2016.
3. Forum heard arguments of both the sides and perused record.
4. Applicant applied for agricultural connection on 22-09-2010 but

demand was issued on 16-10-2010. Demand was paid on 23-02-2011. Test report was given on 23-02-2011. Supply is released on 07-08-2016.

5. It is a matter of record that previously applicant filed case no.479/2012 before this forum. It was partly allowed as per order dated 10-10-2012. Applicant filed case No.14/2013 before Hon'ble Electricity Ombudsman, Nagpur & it was allowed as per order dated 170402013. As per the order of Hon'ble Electricity Ombudsman Nagpur supply is given on 07-08-2015. Out of the compensation amount MSEDCL issued only 2 cheques respectively for Rs.7500/- & Rs.4200/-. Compensation is received till August-2013. Further compensation is not paid as per order of Hon'ble Electricity Ombudsman Nagpur. Therefore applicant approached to this forum. **According to Regulation 6.7(d) of the said Regulation, “Forum shall not entertain grievance where a representation by the same consumer in respect of same grievance is already decided by Electricity Ombudsman”**. Therefore present application is not tenable at Law.

6. If order of Hon'ble Electricity Ombudsman Nagpur is not fully complied then applicant is at liberty to file a matter under section 142 of Electricity Act 2003 before appropriate authority. This forum is not executing authority to execute orders passed by Hon'ble Electricity Ombudsman.

7. Therefore grievance application deserves to be dismissed. Hence the following order.
